

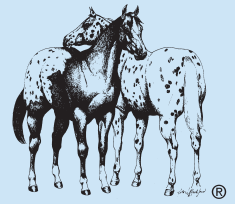

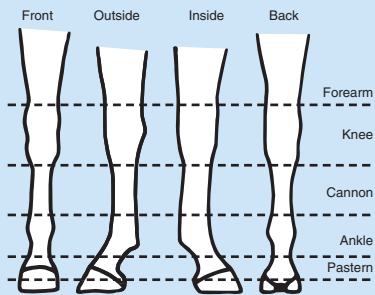

ELIGIBILITY

1. For Tentative or Permanent registration, pony must have Appaloosa characteristics (sclera and mottled skin) and color. **One Parent must be a registered POA, unless hardship clause is satisfied.**

2. At maturity pony must be 46" and not over 56" if pony matures under 45" or over 56", its pedigree will be voided and the registration fee forfeited unless said POA is transferred to ID pink papers. This requires POAs pedigree, completed inspection form, \$10, recent picture.

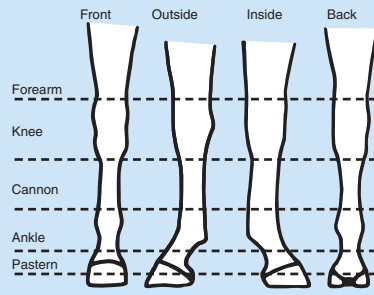
3. If foal is born solid colored, it is eligible for ID Registry, Blue Papers. This application must be filled out and signed and accompanied by two pictures, breeder's certificate and proper fee. If color develops later application may be made to change to Tentative or Permanent registry. Send clear pictures, fee and completed application.

4. ID ponies, both pink and blue papers, are not eligible to show, but do qualify as the registered parent for a foal.

GENERAL

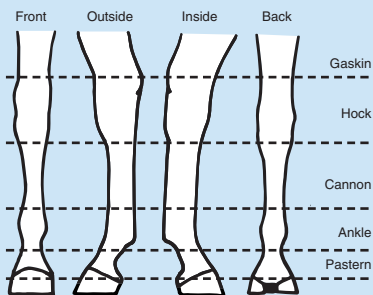
